Executive Response to the Final Report and Recommendations of the Working Together to Address the Impact of Heavy Goods Vehicles/HCVs on Roads in Staffordshire

Recommendations

- 1. That the Prosperous Staffordshire Select Committee receives the formal response of Portfolio Holder to the recommendations of the 'Working Together to Address the Impact of Heavy Goods Vehicles/HCVs on Roads in Staffordshire' Scrutiny Review.
- 2. That the Prosperous Staffordshire Select Committee considers the content of the accompanying action plan.
- 3. That the Prosperous Staffordshire Select Committee monitors the action plan and implementation of the agreed recommendations on a six monthly exception basis, until all recommendations have been fully implemented.

Report of Cllr Mark Deaville, Cabinet Member for Highways and Transport

Summary

What is the Select Committee being asked to do and why?

- 4. The Portfolio holder recognizes the work of the Member Working Group and welcomes the conclusions and recommendations of their report. Having reviewed the 24 recommendations it is noted that 11 of the recommendations will have been completed by the end of 2016 and a further seven are the subject of on-going 'business as usual' activities. The remaining six recommendations have significant resource implications and have been placed on-hold this financial year but will be considered for funding in 2017/18 alongside other priorities as part of the annual budget review process. In terms of the specifics of the HCVs using the A515, some heavy goods traffic will need access to drop off/pick up in the communities along the route as well as communities served off the A515. However, there is also potentially other heavy through traffic, but we need evidence to understand this much better to put the right solution in place. We will work with the local parish councils and local councillors to develop this evidence base. Clearly any through HCV traffic should be encouraged to use the most appropriate route which minimises the impact on Staffordshire's communities. We will also work with the local parish councils to consider any interim solutions.
- 5. In view of the above the Prosperous Staffordshire Select Committee are asked to receive the formal response to the final report and recommendations of the 'Working Together to Address the Impact of Heavy Goods Vehicles/HCVs on Roads in Staffordshire' Scrutiny Review and to make arrangements to monitor the plan for

implementing the agreed recommendations – to make sure that action is taken and delivers the intended outcome.

Report

Background

- 6. The Prosperous Staffordshire Select Committee nominated a Member Working Group to undertake a review into the impact of HGV traffic on Staffordshire's roads as a result of two petitions that were submitted to Full Council in May 2015. The aim was to hear evidence from a range of organisations and then to suggest a number of recommendations which aimed to minimise the impact of HGV traffic on impacted communities.
- 7. The findings and recommendations of the Scrutiny Working Group were endorsed by the Prosperous Staffordshire Select Committee at their meeting on 24 May 2016. The report was then submitted to Portfolio Holder with a request for his formal response. All of the recommendations were agreed.
- 8. Attached as an Appendix to this report is a table setting out:
 - a. each of the agreed recommendations;
 - b. the organisation/lead Member or officer;
 - c. the action proposed (or already taken) in response to the agreed recommendations; and
 - d. a deadline for completion.

Community Impact

- 9. A formal community impact assessment has not been carried out at this time but it is recognised that all forms of traffic impact on communities living close to the highway. As the freight strategy is developed careful consideration will need to be given to ensure that any particular routing developed does not solve one community problem but create another. This is particularly true of HCV's using the Staffordshire primary route network and when implementing local solutions we need to ensure that HCV traffic is not diverted onto less suitable roads with corresponding adverse impact on local communities.
- 10. Staffordshire County Council and local planning authorities will need to continue to work closely together as local plans are developed so that HCV traffic that is generated as a consequence of economic growth is considered on a whole county basis in terms of the available highway network and the communities living along those networks.

Future Operating Model for Staffordshire's Arts Service

Recommendation/s

- 1. To consider the proposal for the Arts Service to vacate the Shire Hall and remodel the Arts Offer to realise a net saving of £62,223. This will enable the Arts Service to achieve their full Medium Term Financial Strategy (MTFS) saving of £118,000 in 2017/18.
- 2. To consider the proposal that Strategic Property investigates alternative proposals for how the space in the Shire Hall can be used so that it is brought back into beneficial use and generates a revenue stream for the County Council to offset the £100,000 pooled property MTFS saving.

Report of CIIr Ian Parry, Deputy Leader and Cabinet Member for Finance and Corporate Matters and CIIr Gill Heath, Cabinet Member for Communities & the Environment

Summary

What is the Select Committee being asked to do and why?

- 3. To comment on the proposals for the Shire Hall and the Arts Service.
- 4. The Library & Arts Service welcomes comments from the Select Committee which will be reported to Cabinet at its meeting on 21st September for it to take into account during its consideration of this matter.

Report

Brief Report Summary

5. This report outlines the proposal to redefine the Arts Service to realise a £62,000 Arts MTFS saving and proposes using the space within the Shire Hall differently to generate an income stream for the county council and offset the £100,000 pooled property MTFS saving.

Background

6. The Great Hall within the Shire Hall building is currently occupied by Staffordshire County Council's Arts Service and Wolverhampton University.

- 7. The rear of the building, formerly occupied by Stafford Library, has been vacant since September 2015 - with the exception of the Multi-Sensory Environment Room which is located at the side of the building and is also managed by the Arts Service.
- 8. There is currently a cumulative MTFS saving of £218,000 predicated on the County Council vacating the Shire Hall which was agreed by Full Council in 2014.
- 9. The saving breaks down as follows:

a. £118,000 Arts Service savings to be delivered by Culture and Communities b. £100,000 pooled property savings to be delivered by Strategic Property

- 10. At present £56,000 efficiency savings have been identified within the 2016/17 Arts budget.
- 11. However in year, there is currently a £62,000 MTFS shortfall from the Arts budget and £100,000 from the Strategic Property budget.

The Arts Service

- 12. Staffordshire County Council's Arts Service current offer includes the following:
 - a. The Shire Hall Gallery
 - i. Shire Hall Gallery Team (4.75 FTE)
 - ii. Exhibitions, events & activities programme
 - iii. Craft shop
 - iv. Multi-Sensory room (MSE room)
 - v. Accredited museum courtroom & cells
 - b. Arts Development
 - i. Arts Development Team (2 FTE)
 - ii. £20,000 Community Arts Grants
 - iii. £10,000 Arts Development Grants
 - iv. £40,000 Service Level Agreement with the New Vic Theatre
- 13. 2015/16 visits to the Shire Hall

Total Visits to Shire Hall Gallery	76,862
Total Virtual Visits	26,658
Number of visit to the MSE room	3,032

- 14. The visits to the Shire Hall Gallery have reduced by 28% since the Library relocated to Staffordshire Place in September 2015.
- 15. Visits to the MSE room have remained more static with a visitor reduction of 4%.

The Shire Hall

- 16. The re-provision of the Arts Offer which was predicated on vacating the Shire Hall Gallery was first agreed by Full Council on Thursday, 13th February, 2014, subject to agreement by Cabinet and an agreed purchaser for the building.
- 17. When the original proposal to vacate the gallery was included in the 2015/16 MTFS a petition to "Save Stafford Shire Hall" was launched with the following wording: "we the undersigned petition the county council to reconsider and reverse the proposals to remove the library, gallery and other facilities from the Shire Hall and sell the building."
- 18. A 1,960 paper signature was presented at Full Council on 13 February 2014 by Councillor Maureen Compton. An additional 955 signature e-petition was received, giving a total of 2,915 signatures. The petition was discussed by the Prosperous Staffordshire Select Committee (PSSC) on 7 March 2014 under the Council's Petition Scheme.
- 19. It was resolved at the PSSC meeting on 7 March to further consider the issue at the committee meeting on 2 June. This discussion did not take place as following receipt of the petition the County Council was approached by Wolverhampton University who required a presence in Stafford town centre.
- 20. Since July 2014, the Great Hall space within the Shire Hall Gallery has been shared with Wolverhampton University under a licence agreement.
- 21. When the licence was granted to Wolverhampton University it was anticipated that partnership working would enable the gallery function to be delivered differently at a reduced cost. This ambition has not been realised and Wolverhampton University have now indicated that they no longer wish to occupy any part of the building.
- 22. Following the decision by Wolverhampton University, Strategic Property are now looking at alternative proposals for how the space in the Shire Hall can be used so that it is brought back into beneficial use and generates a revenue stream for the Council.
- 23. There is now a pressing need to realise the 2016/17 £218,000 MTFS savings that were agreed by Full Council on Thursday, 13th February, 2014.
- 24. £59,000 was saved by the Arts Service during 2015/16 through deleting a vacant post and a range of efficiency savings leaving an ongoing budget gap of £59,000 which was offset by managed vacancy control savings within the Culture & Communities budget.
- 25. Strategic Property anticipate that their £100,000 saving can be offset by using the Shire Hall differently and generating an income. There are currently no plans to sell the Shire Hall.

Redefined Arts Offer

26. To enable the Arts Service to deliver a minimum of £62,000 to achieve their full MTFS saving of £118,000 in 2017/18 it is proposed that the Arts Service is re-defined and vacates the Shire Hall.

- 27. Alongside this Strategic Property will explore developing the Shire Hall building as multipurpose space.
- 28. In re-defining the Arts Offer we propose to:
 - a. Focus on community arts provision, retaining Arts Development, Exhibitions and Community Arts officer posts to enable us to deliver the offer
 - b. Deliver County-wide 'Pop up' Service utilising new and existing venues (SCC, Districts & Boroughs)
 - c. Cease to deliver an annual exhibition programme in the Shire Hall
 - d. Discontinue the craft shop & museum
 - e. Explore re-providing the multi-sensory room
 - f. Explore developing the Shire Hall building as multi-purpose space
- 29. This proposal will result in deleting 3.75 FTE which will give staff savings of £86,153 (including on costs) and the cost of redundancies will be in the region of £97,788.92.
- 30. We anticipate that there will be some income (in the region of £5,000) from pop up exhibitions but with a projected loss of £13,900 exhibitions income and £56,480 craft shop income the **net savings for the Arts Service will be £62,223** (this does not include the cost of redundancies or redundancy loan).
- 31. The timescales should the proposal be agreed are as follows:

- 32. Encourage local people to participate in social and leisure activities that they enjoy by promoting the attractiveness of the County to businesses and residents
- 33. Re-define the Arts Offer and create and manage a solution to the Shire Hall

Link to Other Overview and Scrutiny Activity

34. The proposal for the Arts Service to vacate the Shire Hall was discussed by the Prosperous Staffordshire Select Committee under the Council's Petition Scheme on 7 March 2014.

Community Impact

35. The proposal has the potential to enable wider access to the arts offer across all age ranges within communities which could minimise disadvantage.

- 36. There is however a potential adverse implication of the proposal if the MSE offer is relocated or discontinued. This could impact on children and people with disabilities who use the MSE room. Alternative options for the MSE room are currently being explored.
- 37. However the County Council already provides alternative access to multi-sensory facilities in the following children's centres: Newcastle, Staffordshire Moorlands, Leyfields, Tamworth and Cannock. These are used by Children's Centre users and SEND children, young people and adults. There are also approximately 10 sensory suitcases, which include a range of sensory play equipment that can be hired from Children's Centres for use at people's homes.

Executive summary of the assessment

Arts and culture enrich our lives. Taking part in and experiencing cultural activities and events can bring communities together and play a positive role in achieving a thriving & prosperous Staffordshire.

Access to arts enables human connection, social interaction and activity that combats isolation and promotes a sense of well-being. Staffordshire Arts enable this through access to community led arts activity which will continue to be supported by the Arts Service.

The remodelled arts offer will ensure that high quality community arts provision is available to all people across the county, increasing opportunities for people to take part in, contribute to and experience the arts in Staffordshire.

There is a potential adverse implication of the proposal if the MSE offer is relocated or discontinued. This could impact on children and people with disabilities who use the MSE room. Alternative options for the MSE room are currently being explored.

However the County Council already provides alternative access to multi-sensory facilities in the following children's centres: Newcastle, Staffordshire Moorlands, Leyfields, Tamworth and Cannock. These are used by Children's Centre users and SEND children, young people and adults. There are also approximately 10 sensory suitcases, which include a range of sensory play equipment that can be hired from Children's Centres for use at people's homes.

Equality analysis

1. Describe in summary the aims, objectives and purpose of the proposal, including desired outcomes.

Background

The Great Hall within the Shire Hall building is currently occupied by Staffordshire County Council's Arts Service and Wolverhampton University.

The rear of the building, formerly occupied by Stafford Library, has been vacant since September 2015 - with the exception of the Multi-Sensory Environment Room which is located at the side of the building and is managed by the Arts Service.

There is currently a cumulative MTFS saving of £218,000 predicated on the County Council vacating the Shire Hall which was agreed by Full Council in 2014.

At present £56,000 efficiency savings have been identified within the 2016/17 Arts budget. However in year, there is currently a £62,000 MTFS shortfall from the Arts budget and £100,000 from the Strategic Property budget.

To enable the Arts Service to deliver a minimum of £62,000 to achieve their full MTFS saving of £118,000 in 2017/18 it is proposed that the Arts Service is re-defined to focus on community arts provision and vacates the Shire Hall.

Alongside this Strategic Property will explore developing the Shire Hall building as multi-purpose space.

The Crown Court vacated the Shire Hall in 1991 and the Arts Service has occupied the Shire Hall Gallery since 1993.

The visits to the Shire Hall Gallery have reduced by 28% since the Library relocated to Staffordshire Place in September 2015. Visits to the MSE room since September have remained more static with a visitor reduction of 4%.

This is illustrated by the January-June figures below. The MSE room was closed during September/October 2016 and therefore a direct comparison with September/October 2015 is not available.

Future Operating Model for Staffordshire's Arts Service

In re-defining the Arts Offer we propose to:

- Focus on community arts provision, retaining Arts Development, Exhibitions and Community Arts officer posts to enable us to deliver the offer in communities
- Deliver County-wide 'Pop up' Service utilising new and existing venues (SCC, Districts & Boroughs) to widen the offer across Staffordshire
- Cease to deliver an annual exhibition programme in the Shire Hall
- Discontinue the craft shop & museum
- Explore re-providing the multi-sensory room

2. Who are the main people that will be affected?

The main groups of people that could be affected by the proposal are gallery staff, gallery visitors, gallery Friends, MSE users, artists, arts groups, makers & exhibitors.

In 2015/16 there were 76,862 visitors to the gallery, 176 people were members of the Friend's Discount Scheme and 3,032 people visited the MSE room.

The gallery currently has 4.75 FTE members of staff and 9 volunteers who provided over 766 volunteer hours in 2015/16.

The following arts groups use space in the gallery to facilitate arts activities:

- Social Hub A face-to-face social support network, deliver a Craft Club and Coffee morning
- Weekly Craft Club
- Creative Health CIC This Way Up programme, run regular art sessions
- Unseen Cinema Cinema Screenings in Court 1

During 2015/16, 8 exhibitions were curated, contracting with175 artists. This includes approximately:

- 62 Staffordshire People who exhibited at Open Art
- 15 makers who sold work at the Christmas Craft Show
- 50 photographers whose work was included in the Royal Photographic Society's annual show

3. Who is currently using the Arts service?

Staffordshire Libraries & Arts Service carries out a Visitor Survey twice a year.

Between April & June 2016 100% of the people surveyed rated their visit to the Gallery as excellent or good.

Overall, visits to the Gallery have declined by 35% in the last 3 years.

During 2015/16

- The total number of visits to the Shire Hall Gallery was 76,862.
- The total number of visits to the Multi-Sensory Room (MSE room) was 3032. The MSE room was closed during September/October 2015 to enable building work to take place. Visits to the MSE room have remained almost static since the library relocated to Staffordshire Place in September 2015 and the MSE room reopened however visits are significantly lower than 2013-14 when 5,482 people used the room.
- A minimum of 20,198 people, benefited from a community arts grant. There are further reports due to be submitted, which could take this total to approximately 30,000 people.
- 136,524 people engaged with Staffordshire's Arts Development managed & funded arts activities/facilities. This includes the 109,787 New Vic attendances and 13,024 participants & 4,422 Live & Local participants.

As part of this proposal, the MSE room will no longer be located in the Shire Hall and managed by the Arts Service. We are currently talking to other organisations to identify an alternative venue and provider of this service.

There will be a negative Community Impact of ceasing to provide the Multisensory room in Stafford if this is relocated to another part of the county.

However the County Council already provides alternative access to multi-sensory facilities in the following children's centres: Newcastle, Staffordshire Moorlands, Leyfields, Tamworth and Cannock. These are used by Children's Centre users and SEND children, young people and adults. There are also approximately 10 sensory suitcases, which include a range of sensory play equipment that can be hired from Children's Centres for use at people's homes.

If this proposal is agreed there will be increased opportunities for people across the county to engage with community arts provision through the continued administration of Community Arts and Arts Development Grants, Arts Development Projects and "pop-up" Community Exhibitions.

In particular South Staffordshire, East Staffordshire, Tamworth & Staffordshire Moorlands communities will be targeted to ensure increased engagement with the remodelled arts offer that will be less Stafford centric.



Figure 4 shows that 91% of the arts team are female and 63% are over 40 indicating that the proposals could have an impact on particular protected groups within the workforce.

It is anticipated that by vacating the gallery that the number of staff required to deliver the Arts Service may be reduced by 3.75 FTE. These proposals would therefore be subject to full consultation with affected staff and their Trade Union representatives.

Staff affected by these changes will be kept informed of proposals and fully supported during the change period by managers and the OD service.

During 2015/16 the Gallery was supported by 9 volunteers.

There will continue to be a range of volunteering opportunities for volunteers across the county to support and enhance the arts offer; however these opportunities would not all be Stafford based.

7. Are there any gaps in your evidence or conclusions that make it difficult for you to quantify potential adverse impact?

We collect limited data on protected groups (see figure 3 – age and disability) and do not have a breakdown of use or visits by race or gender.

There is a potential adverse impact of ceasing to provide the Multisensory room in Stafford if this is relocated to another part of the county, however as described on page 7 the County Council does provide access to multi-sensory facilities for Children's Centre users, SEND children, young people and adults at 4 Children's Centres across the county.

8. If so, please explain how you will explore the proposal in greater depth

Strategic Property are currently identifying the cost of re locating the Multisensory room to an alternative venue within Stafford and various options are being explored.

There will be a cultural impact of ceasing to offer permanent exhibition space in Stafford town centre if the Arts Service vacates the Shire Hall which will be mitigated through the provision of a wider community focussed arts offer. Conversations with stakeholders and communities will be held to help to shape this offer.

The relationship with artists, makers and community organisations that currently exhibit in or use the Shire Hall will need to be managed carefully. Exhibitions have not been programmed from April 2017 to reduce the risk of cancelling contracts with exhibitors which has a financial implication. If the proposal is agreed, all exhibitors will be contacted directly by the Arts Service to ensure they are fully aware of the future operating model for Staffordshire's Arts Service

9. Please provide details of all consultation undertaken specific to the proposal you are making, either prior to the CIA or as part of it and the results of this.

When the original proposal to vacate the gallery was included in the 2015/16 MTFS a petition to "Save Stafford Shire Hall" was launched with the following wording: "we the undersigned petition the county council to reconsider and reverse the proposals to remove the library, gallery and other facilities from the Shire Hall and sell the building."

A 1,960 paper signature was presented at Full Council on 13 February 2014 by Councillor Maureen Compton. An additional 955 signature e-petition was received, giving a total of 2,915 signatures. The petition was discussed by the Prosperous Staffordshire Select Committee (PSSC) on 7 March 2014 under the Council's Petition Scheme.

The signatures represent only 2.5% of our annual visitors and 0.3% of the population of Staffordshire

10. Consultation with customers & stakeholders

We invite continual feedback via comments books in the Gallery and a comments wall in the MSE Room. Feedback is also gathered face to face. Specific targeted exhibition consultation is carried out when required or in line with funding requirements. Ongoing informal consultation will continue to enable the service to develop a community arts focussed offer that is relevant to communities.

We will engage stakeholders in relation to identifying an alternative location for the MSE room but there are no plans to conduct formal public consultation about the proposal.

11. Consultation with staff

Staff will be briefed informally during the week beginning September 5th 2016.

The proposal will be discussed at the Trade Union Consultative Forum on 6th September 2016.

If these proposals are approved then they will be subject to full consultation with affected staff and their trade Union representatives.

We will ensure that the member of staff on maternity leave is also included as part of the briefing process.

12. Making a decision

The following are key dates for decisions to be made regarding the future operating model for Staffordshire's Arts Service:

13th February 2014 – Full Council: The re-provision of the Arts offer, predicated on vacating the Shire Hall Gallery, was agreed subject to agreement by Cabinet and an agreed purchaser for the building.

13th September 2016 – Prosperous Staffordshire Select Committee: Comments will be reported to Cabinet at their meeting on 21st September for them to take into account as part of the decision making process.

21st September 2016 – Cabinet Meeting: Decision to be made on the future operating model for Staffordshire's Arts Service, including the Arts Service vacating the Shire Hall.

There are no plans currently to sell the Shire Hall, Strategic Property are investigating alternative proposals for how the space in the building can be used so that it is brought back into beneficial use and generates a revenue stream for the Council to offset the £100,000 pooled property MTFS saving.

Entrust will be commissioned to undertake a feasibility study to identify likely cost implications of re-purposing the building which will be used to inform an outline business case.

Wolverhampton University have recently indicated that they no longer wish to occupy any part of the Shire Hall and there is a possibility that Wolverhampton University may have vacated the building prior to the completion of the business cases.

At this stage the University have yet to serve notice terminating the licence agreement. If this transpires then it may be necessary to have some security measures put in place to keep the building secured.

There is significant reputational risk of vacating an historic Grade 2* listed building in the centre of Stafford when flagship stores are relocating into the new town centre development.

Options will be explored to identify an alternative location for the MSE room however a suitable alternative has not yet been identified.

13. Actions

We will pay due regard to our Public Sector Equality Duty and ensure that as we develop the future operating model for Staffordshire's Arts Service, the needs of protected groups will be considered.

In particular we will endeavour to secure an alternative location for the MSE room to mitigate the impact on regular users of this facility.

Reshaping the arts offer to give an increased community focus should widen access to arts provision for protected groups.

If the proposals are agreed then there will be full consultation with affected staff and their trade Union representatives.

The timescales should the proposal be agreed are as follows:

A detailed action plan will be developed to ensure effective implementation of a realigned model for Staffordshire's Arts Service. The actions within the plan will be monitored by Staffordshire's Library & Arts Manager.

14. Monitoring and review

If the proposal is agreed then work will be undertaken to monitor the development of the wider arts offer which will be reviewed on an ongoing basis to ensure that we continue to deliver a high quality arts service for Staffordshire residents.

Briefing Report: On-street Parking Enforcement and Residents Parking Zones

Purpose

This briefing paper has been prepared to help identify lines of enquiry for the scrutiny of parking enforcement activity during December 2016.

Responsibilities for parking enforcement

Since the decriminalisation of parking enforcement in 2008 enforcement powers have been shared between local authorities and the police.

Prior to April 2015 on-street enforcement was carried out on behalf of the County Council by each of the eight district/borough councils.

In April 2015 arrangements changed and the County Council entered into a single arrangement with Stoke-on-Trent City Council for enforcement and back office services.

The district/borough councils remain responsible for off-street enforcement in their public car parks with four districts using the services of Stoke-on-Trent City Council for enforcement and all using the back office services of Stoke for processing of penalty charge notices.

As part of this change the County Council now deals with all enquiries for on-street parking and enforcement. A new series of parking pages on the County Councils website was introduced in April 2015 including frequently asked questions and payment system for on-street penalty charge notices.

Staffordshire County Council is able to carry out enforcement where parking restrictions exist. The Council can also issue penalty charge notices to vehicles that are blocking pedestrian/disabled crossing points and vehicle access crossings where other parking restrictions do not exist. Enforcement of vehicle access crossings is only carried out at the request of and, with the property owner's permission. Enforcement can also be carried out where vehicles are double parked i.e. parked more than 50cm from the kerb.

Any issues of vehicles parked dangerously or causing an obstruction remains a matter for the police. The police can also address offences of wilful and unnecessary obstruction on the road or pavement, the blocking of pedestrian/disabled crossing points and vehicle access crossings, dangerous parking on chevrons at pedestrian crossings etc., and issues of double parking or parking too close to a junction.

With the exception of dropped kerb crossing points and double parking local authorities can only enforce where parking restrictions exist and Staffordshire County Council is therefore able to enforce the following:

- limited waiting bays
- double/single yellow lines
- on street pay and display bays
- resident parking zones
- disabled parking bays
- loading bays
- bus stops/stands
- taxi bays
- school keep clears (where a traffic regulation order is in place)
- clearways
- dropped kerb access (written consent from the property owner is required)
- double parking (vehicles parked too far from the kerb line)
- pedestrian crossings (also police)

In addition the above civil parking offences, the police are responsible for enforcement of the following:

- Illegal obstructions and dangerous parking
- double white lines (moving traffic offence to restrict overtaking)
- obstruction e.g. pavements with no parking restrictions
- dangerous parking where there are no restrictions in place, for example, on bends, brows of hills and junctions
- dropped kerb access (where obstruction is being caused see also local authority powers)
- double parking (where obstruction is being caused i.e. vehicles parked obstructively either side of the road see also local authority powers)
- one-way traffic
- box junctions
- access only
- white-hatched areas
- pedestrian crossings (also local authority)

Clear Streets – Civil Parking Enforcement

Each year the County Council is required to prepare an annual report on civil parking enforcement. The report for the first year of the new arrangement is currently being prepared and will be brought to a future meeting of the Committee.

Some headline results for this year are:

Public satisfaction with measures to tackle inconsiderate parking continues to improve (annual NHT Public Satisfaction Survey) have slightly improved 44.4% in 2015 compared to 42.6% in 2014

The level of Penalty Charge Notices issued in 2015/16 decreased compared to 2014/15 with 19,763 issued compared with 21,261 in 2014/15.

The percentage of Penalty Charge Notices issued for which payment has been received, has increased (75% in 2015/16 compared to 72% in 2014/15). Over 82% of Penalty Charge Notices payments received are paid for at the discounted rate.

26% of Penalty Charge Notices issued receive representations

Of those Penalty Charge Notices that receive representation, 42% are cancelled in accordance with the Policy for the Processing of Penalty Charge Notices. The majority of cancellations are related to failure to correctly display blue badges or paid for parking tickets.

Less than 1 in 1,000 tickets are referred to appeal at the Traffic Penalty Tribunal with only 9 cases allowed demonstrating that good policies are in place, good decisions are being made locally by enforcement staff during representations to Stoke-on-Trent City Council Parking service and by County Council officers. 261,807 observations/visits were carried out. 10,098 enquiries dealt with by the contact centre (July 2015-March 2016). Approximately 500 enquiries/requests for enforcement were dealt with by the County Councils Clear streets team each month.

Residents' Parking Zones

Before decriminalised parking enforcement (DPE)/civil parking enforcement (CPE) the County Council was unable to introduce Permit Parking Schemes as they required high levels of enforcement that the Police were unable to supply. With the introduction of DPE/CPE, the County Council was able to develop a policy to determine the selection, type, operational constraints and terms and conditions for the introduction of these permitted parking schemes and the Policy and Guidelines for Residents Parking was developed for that purpose.

The intention of a Residents' Parking Zone (RPZ) is to give residents priority and manage non-residents parking in the zone. The introduction of a scheme does not mean that residents have their own parking spaces, nor does it guarantee every householder a parking space within the zone at all times.

In 2013 the Joint Staffordshire Parking Board recommended the introduction of additional guidelines for the development of an RPZ focussed on the development of the role of a "Local Champion" who has a key role in demonstrating that there is majority support and acting as a link between the traffic regulation team and residents and businesses within the zone. This approach supports localism and the Local Champion could, for example be a resident, the local County Councillor or a member of the district, parish or town council.

There is currently 6 Residents Parking Zone in operation across the county at the following locations. Together over 475 properties are covered by the various zones with 470 permits being issued in a typical year.

• Victoria Street, Cannock (25 Premises)

- Lombard Street, Lichfield (34 Premises)
- Castletown, Stafford (159 Premises)
- Vessey Terrace (and surrounding streets), Newcastle (200 Premises)
- High Green, Brewood, South Staffordshire. (9 Premises)
- Cherry St & Cross St, Tamworth. (48 Premises)
- Since April 2015 the following new zones have been introduced
- Cherry St & Cross St, Tamworth. (48Premises)

Based on the priorities previously agreed by the eight district local parking committees the following zones are either currently under development or have not been progressed. This is generally due to either not obtaining the required level of support or other technical issues such as suitability e.g. inadequate number of spaces.

Zones under development:

- Victoria Road area, Tamworth (172 premises, estimated date of introduction winter 2016/17)
- Queen's Hospital area, Burton upon Trent (663 premises, estimated date of introduction summer 2017)
- Forebridge west, Stafford (226 premises, estimated date of introduction winter 2016)
- Forebridge east, Stafford (370 premises, estimated date of introduction spring 2017)
- Brunswick Terrace, Stafford (47 premises, estimated date of introduction summer 2017)
- Dunkirk / Stanier area Newcastle under Lyme (446 premises, estimated date of introduction autumn 2017)

Zones that have not been progressed

Newhall Street, Cannock (143 Premises). During the initial design stage of the scheme it became evident that there was a considerable lack of road space available for parking when considering the number of vehicles that the properties who wished to join the scheme owned.

Requests for the development of zones remain high with 15 requests received since April 2015. The County Council's highways team is currently resourced to be able to progress a maximum of two schemes in each financial year.

Since April 2015 permit types have been simplified and in July 2016 an online application system for permits was introduced making it easier for residents to apply for new or renewed permits and supporting the county councils shift to digitally enabled services.
