Schools Forum – 11 January 2017

Schools Budget 2017-18: Budget Approval for Central Services to Education previously funded by Education Services Grant (ESG)

Recommendation

- 1. That the Schools Forum approve the amount of £1,768,917 in 2017-18 to fund services previously funded by the ESG retained duties.
- 2. That the Schools Forum members from maintained schools only, approve the rate of £1 per pupil in 2017-18 (after taking the transitional funding into account – based on current assumptions this would rise to £24.46 in 2018-19) to fund statutory duties performed by the Local Authority and previously funded by the ESG general duties rate.
- 3. That maintained Schools Forum members vote on whether additional amounts per pupil are levied from schools budgets' to pay for the LA to provide asset management services and meet 30% of redundancy lump sum payments.
- 4. That any further decisions on this matter be delegated to the Director of Finance and Resources.

Report of the Director of Finance and Resources

Why is it coming here – what decision is required?

- 5. Schools Forum members are required to approve an amount of funding to be retained centrally by the LA to fund statutory and regulatory duties that would have previously been funded notionally through the Education Services Grant (ESG).
- 6. Until 2017-18, ESG was made up of two rates that 'notionally' funded two different groups of services:
 - a. The retained duties rate (£15 per pupil).
 - b. The general duties rate. This funding will cease to exist from September 2017, with a transitional rate per pupil for the financial year 2017-18.
- 7. The retained duties will be voted on by all schools including academies. Duties funded by general ESG funding will be voted on by maintained schools only.
- 8. If the Local Authority and Schools Forum are unable to reach consensus on the amount to be retained by the Local Authority, the matter will need to be referred to the Secretary of State.

Background

9. The ESG has contributed to funding central services to education. The total cost of these functions in 2016-17 was £13.856m and has been funded by a combination of

Council Tax, ESG and DSG. The table below breaks down how this expenditure is funded.

- 10. The Teachers Pensions Added Years has been funded through Council Tax. This is an annual liability of c.£7.1m reflected in the table above. The County Council will continue to fund this in 2017-18.
- 11. As outlined above, from 17/18 onwards the ESG will cease to exist in its current form. Alternative arrangements now need to be put in place.

Retained Duties

12. The functions provided to all schools and previously funded by the retained duties ESG rate are listed in the table in Appendix 1, along with an estimate of the total funding to be added into the schools block for retained duties.

Do Schools Forum members approve an allocation of £1,768,917 to fund these services?

General Duties

- 13. The functions provided to maintained schools only and previously funded by the general duties ESG rate can be split into two sections: functions performed by the Local Authority, and functions that can be provided by the LA or delegated to schools.
- 14. The table outlined in Appendix 2 shows the functions performed by the LA for maintained schools.
- 15. The Local Authority will need to levy £1 per pupil from maintained schools in order to cover the cost of these services.

Do maintained Schools Forum members agree with the list of general duties costed in appendix 2?

Do maintained Schools Forum members agree with the levy of £24.46 to fund the costs associated with the general duties?

Do maintained Schools Forum members agree to utilise the 2017-18 transitional funding to fund the general duties, reducing the levy required from maintained schools in 2017-18 to £1 per pupil?

16. Functions that can be performed by the Local Authority for maintained schools or can be delegated to schools are shown in Appendix 3.

Do maintained Schools Forum members approve a levy of £23.74 per pupil to fund Asset Management? (As previously mentioned within the ESG briefing note)

Do maintained Schools Forum members approve a levy of £21.90 per pupil to fund 30% of redundancy lump sum costs? (As previously mentioned within the ESG briefing note)

- Strategic overview to promote high standards in primary and secondary education
- Engagement with regulatory bodies including DfE, Regional Schools Commissioner (RSC) and Ofsted
- Engagement with other bodies and individuals including Diocese, Trade Union, potential academy sponsors, public etc
- Strategic management of number of sessions and their times schools must hold in a year
