PART ONE

Minutes

67. **RESOLVED** – That the minutes of the meeting held on 23 March 2015 be confirmed and signed by the Chairman.

Matters Arising

68. There were no matters arising which were not dealt with elsewhere on the Agenda.

Joint Waste Management Board Sub Group - Update

(Schedule 1)

69. The Board received the minutes of the Joint Waste Management Board Sub-Group meeting held on 1 July 2015 for information which included progress reports in respect of the following projects:-

- Food Waste Prevention Project Group (closed project);
- Developer Bin Policy (closed project);
- Fleet Procurement (closed project);
- Dry Recyclables Processing Contract Procurement (on-going project);
- Four Ashes Joint Campaign (on-going project);
- Holistic Savings for Staffordshire (new Project)

Members noted the good progress which had been made in various projects, including those which had been completed since their previous meeting. With regard to the Food Waste Prevention Project, Fun Food Packs had been launched and circulated to all Partner Authorities. The packs had also had also been made available on the Staffordshire Waste Partnership Website and publicised in the press.

The Developer Bin Policy, the Waste Guidance for Developers document had been completed and issued to all Partner Authorities for implementation as necessary. Included in the document was a method of payment for Councils wishing to charge for the provision of bins.

With regard to Fleet Procurement, East Staffordshire Borough Council had recently let their fleet contract to Gulliver's with assistance from the Staffordshire Waste Partnership Officer who had moderated the tender evaluation process as an impartial advisor. The Waste Partnership Officer had also assisted the Borough Council during a potential legal challenge by the second place tenderer and offered to moderate Lichfield District and Tamworth Borough Council's tender evaluation for their Fleet contract.

70. **RESOLVED** – That the reports be received and the progress on projects made to date be noted.

Strategic Waste Management Action Plan - Performance Report (Schedule 2)

71. The Board considered a report of the Chairman of the Staffordshire Waste Officers' Group regarding the progress made towards delivery of the Strategic Waste Management Action Plan.

From the data which had been received, most Authorities had collected less residual waste per household (NI191) in this period (quarter 4) when compared to quarter 3 2014/15. This trend was also reflected in the year end statistics. However, performance under NI192: "Household Waste Sent for Reuse, Recycling or Composting" had also declined for all Partners when compared to quarter 3 2014/15. With regard to NI193: "% of municipal waste landfilled", the County Council's performance indicated a slight reduction (0.34%) in the current period compared to Quarter 3. Members noted that the quarterly statistics for Stoke-on-Trent City Council were unavailable although the year-end total was 10.62%.

Members were pleased to note the decrease in residual waste collected but looked forward to an improvement in the statistics for waste recycled and sent to landfill. They were agreed over the urgent need to continue promoting the message of 'Reduce, Reuse and Recycle' with the public for both environmental and financial reasons.

72. **RESOLVED** – That the report be received and noted.

Reports for Information

(Schedule 3)

73. The Board received a Briefing Note from the Staffordshire Waste Partnership Officer – Waste Management Savings (as submitted to the Staffordshire Chief Executive's Group at their meeting on 9 July 2015).

The note had been prepared following a request by Members at their previous meeting and set out the background to the discussions which had already taken place regarding Staffordshire County Council's aim of achieving financial savings of £1.5m in their waste management operations over the next five years (as set out in their Medium Term Financial Strategy 2015-2020). The Authority had initially proposed that (i) a reduced level of Green Waste Credits (GWC) should be paid to District and Borough Councils in instances where they were intending to charge for Green Waste collections (to ensure that both collection and disposal Authorities benefitted from the additional income received) and; (ii) the abolition of the automatic annual 3% inflationary increase in credits paid to Waste Collection Authorities.

However, following the meeting of the Board on 23 March 2015 at which Members had opposed the proposals stating that there was no political appetite to introduce a chargeable service at present, various other options had initially been considered including (i) freezing the annual 3% inflationary increase in GWC for three years; (ii) linking the annual increase to the Consumer Price Index and; (iii) recalculating the rate of GWCs which had originally been fixed in 2006.

In addition, the note detailed all other possible options for achieving disposal savings (having regard to the onus being on the Waste Disposal Authority) together with holistic longer term waste management savings for the entire Partnership in order to provide cost effective services for the residents of Staffordshire going forward. These included financial adjustments and soft measures such as a review of staffing levels and salaries etc.

74. **RESOLVED** – That the briefing note be received.

PART TWO

Achieving Savings in Waste Management

(exemption paragraph 3) (Schedule 4)

77. The Chairman of the Staffordshire Waste Officers' Group introduced Dr. David Greenfield, an advisor to the Waste Network Co-ordinators, who had a wide knowledge of Local Authorities nationwide that had been required to make savings in their waste management and other operations. Dr. Greenfield had offered to help facilitate the Board's discussion of the issues set out above, as an impartial advisor, with a view to ensuring suitable actions were taken to avoid cost shunting and achieve holistic savings for all partners.

The Board then received the following oral reports/PowerPoint presentations:-

- Savings (attached as Appendix A to the signed minutes) from Chris Jones, Team Manager: Waste Policy and Climate Change.
- Joint Working (attached as Appendix B to the signed minutes) from Dr. Greenfield and the Staffordshire Waste Partnership Officer.

During his presentation, Mr Jones explained that the County Council had already achieved significant savings in waste management in recent years including (i) £70,000 from the re-classification of Clinical Waste; (ii) £3m from a reduction in landfill and; (iii) £240,000 from a new Household Waste Recycling Centre (HRWC) Contract. In addition, income had been generated from the implementation of Schedule 2 charges relating to the collection of waste from non-residential premises.

Further measures identified for implementation included the introduction of charging for non-household waste at HWRCs and the retender of the Hanford Waste to Energy Contract. However, the remaining options available for achieving the £1.5m target set out in the Authority's Medium Term Financial Strategy 2015-2020 were limited and centred around modifications to the current HWRC contract eg rationalisation of site provision and the introduction of permitting schemes.

The meeting then adjourned so that Members could examine the various options in greater detail in an informal setting. With the assistance of the Staffordshire Waste Partnership Officer, they focused on short term options as set out above. Meanwhile officers from all Partner Authorities together with Dr. Greenfield focussed on the longer term with a view to achieving savings for all Staffordshire residents.

Following the recommencement of the meeting, the Vice-Chairman took the Chair owing to the Chairman having a prior engagement at her Authority.

The Waste Partnership Officer reported that during their group session, Members had provisionally agreed to seek approval from their respective Authorities' Cabinets to annual increases in Green Waste Recycling Credits for 2016/17 and 2017/18 being in line with the Retail Price Index. In addition, the representative of the County Council had agreed that her Authority should re-examine their policy with regard to HWRC provision with a view to releasing further savings where appropriate.

The Member representative of Lichfield District Council said that District and Borough Partners had provisionally agreed to re-examine their waste minimisation strategies with a view to seeking further reductions in the volume of residual waste generated, including undertaking further publicity campaigns to achieve desired outcomes, if required.

Dr. Greenfield informed the Board that during their group session officers had agreed to (i) establish a baseline cost for the waste collection service at their respective Authorities; (ii) explore opportunities for greater joint working between Partner and neighbouring Authorities and for an options appraisal to be prepared for consideration by Members at the appropriate time and; (iii) Having regard to the circular economy whereby growth was decoupled from the use of natural resources, examine how the waste collection and disposal functions could be future proofed against changes in demand and financial constraints of Partners.

78. **RESOLVED** – (a) That Partners seek approval to Green Waste Recycling Credits for 2016/17 and 2017/18 being in line with the Retail Price Index rather than an automatic 3% increase as at present, with a view to reporting back to the next meeting of the Board, so that a Partnership-Wide decision may be made.

(b) That District and Borough Partners re-examine their Waste Minimisation Strategies with a view to seeking further reductions in residual waste including undertaking additional publicity campaigns, if required.

(c) That the Waste Partnership Officer informs the Chief Executive's Group of the above-mentioned proposals.

(d) That the Waste Partnership Officer produce a plan of action and baseline costing spreadsheet using a standard methodology together with any other required documentation to form the background assessments for presentation to the Board at their next meeting in October 2015.

PROJECT PROGRESS REPORT

Closed projects

Food waste prevention project group

The educational food waste and nutrition packs have been available to the public for several months now. Below is a list of the works to disseminate the packs in each council's areas. It is recommended to Members that they enquire to their Waste Manager about their local dissemination to ensure they are receiving the greatest benefit from the packs, to tackle local food waste levels.

Councils;

- Available to download on SWP and SCC website,
- Some councils have emailed the link to schools directly or via eco schools newsletter,
- Some councils have discussed the packs at Eco Schools meetings'
- Showcased at local events, such as ESBC's Autumn festival and Gardening festival or inclusion by SBC in the 'Know your Food Labels/Cooking for One' courses organised by Stafford & Rural Homes for their tenants.

Partners;

- Entrust have incorporated it within their 'Beyond the Kitchen' initiative with schools which is a range of educational toolkits on nutrition, waste, wellbeing and basic cookery, being delivered at over 400 sites.
- Awaiting confirmation of inclusion in adult and family learning courses, along with education delivered by SoTCC City Catering for schools.

Dry recyclables processing contract procurement

The processing contract is now well underway and no longer requires SWP input as initial teething issues have been rectified. SWP support remains available if required.

On-going projects

Four Ashes joint campaign

Following meetings between the councils' working group and Veolia, we are awaiting progress from Veolia as the project lead. Nothing has been progressed for several months despite regular chasing.

CCDC collection contract

CCDC are currently procuring a waste collection contract, which has been open to market during the summer. The council wish to submit an in house bid using their own Waste Officers, therefore meaning they can have no part in the procurement process. CCDC have hired the SWP Manager as a

third party impartial technical officer for the creation of the ITT questionnaire and subsequent evaluation (along with the Waste Officer from SSDC). Evaluation is underway and the contract will be awarded shortly.

This work is undertaken on a consultancy basis for which CCDC are paying for the services of the SWP Manager at a day rate (agreed at SWOG by all councils – consultancy is also open to other council at the same rate if requested, provided the workload does not exceed set parameters affecting the partnership work). Upon project completion, CCDC will be invoiced and the money will go into the SWP pot for use on future joint projects.

Holistic savings for Staffordshire

Following the last JWMB, the SWP Manager has been collating the required data for a baseline costings review, which will be provided at October's JWMB as papers. The information will include full service costs of all waste services across the area, comparisons to 2007 data, and an up to date contract register. These papers will also be submitted to Chief Executive's Group for information.

The SWP Manager also attended the September Chief Executive's Group to provide technical support to their waste discussions and provided impartial feedback on the drafted Memorandum of Understanding.

SWP applied for a grant of £20,000 from the Local Government Association (LGA) to assist with this work, and was successful in its bid. The funding has now been placed in the SWP account ready for use (before March 2016). A condition of the funding is to provide information to the LGA on the project works to ensure the money has been spent to suitably move the authorities forward to greater service and financial efficiencies.

It is expected that after the October JWMB, a direction of travel will have been agreed and a suitable options appraisal will be conducted with outside support (funded by the LGA grant).

New projects

Love your bin man

'Love your bin man' is a SSDC campaign to humanise the waste operations staff to raise health and safety awareness of the dangers our staff face when collecting waste, such as dangerous driving by the public. Following the work already conducted by SSDC, a template has been created to allow other councils to follow the same model.

WEEE funding application

BIS have launched a new WEEE funding scheme offering up to £100,000 for a successful partnering bid. SWP will work with SCC to co-ordinate a suitable application – at present, it is expected that the bid will comprise a push of existing kerbside WEEE collections and assistance to create new kerbside WEEE collections, for those interested councils.

This will further support the SCC led social media project on WEEE reuse at the Rugeley reuse shop (at the HWRC) which received funding in a previous round of applications several months ago.

CPC training collaborations

Following recent discussions at TOG, there are plans to investigate the potential of collaborative driver training for all SWP councils, to achieve economies of scale (therefore reducing costs) and to offer greater flexibility in the logistics of mandatory training. There are several keys options available at a variety of costs – a full options appraisal will be drafted with recommendations, before requesting approval from councils for official adopting.

Item 6a. Overview report

Introduction

This report, as item 6a, provides an overview of the tables and spreadsheets that form agenda items 6b, 6c and 6d;

- 6b SWP Baseline review spreadsheet and summary table,
- 6c SWP Comparison table,
- 6d SWP Contracts register.

Along with other considerations to be aware of.

The information is provided to Members to offer the knowledge required to determine the future direction of the Partnership with regard to achieving holistic saving.

Explanation of 6b

This spreadsheet comprises a baseline financial review of each council waste management services for 2014/15. The template is the same for all councils where appropriate (variances between certain categories for collection, disposal and unitary), to ensure all data has been collated using the same methodology. Each council has supplied their own data to SWP for collation and has been approved at SWOG.

Due to the size of the spreadsheets for 10 councils, this excel document has been emailed to all JMWB attendees rather than issued as paper copies. A summary table, containing the end calculations of the in-depth spreadsheets, has been issued as a paper copy and will be discussed at the meeting.

The spreadsheets calculate the cost to each council of delivering their waste management services. This has been separated into two costs;

- a total cost includes all recharges which has been appropriated to the services, such as recharges for legal, audit and HR services,
- a true service cost which includes only charges relating directly to the running of all waste management services.

These costs are then divided by the number of the households to offer a value comparable between councils by accounting for the population of the areas. However it should be noted that the geographical size, the urban to rural density or the topography of the area cannot be accounted for within calculations.

Explanation of 6c

The effectiveness of the waste management services across SWP is reported to JWMB by recycling rate figures. To highlight the improvement in recycling rates in recent years, a comparison table shows the recycling rate for 2006/07 compared to 2014/15 (the same year offering the financial assessment in item 6b). This indicates that all councils

within SWP have increased their recycling rate significantly over the last 8 years, and are above the UK average for all local authorities.

2006/07 rates were used as this year offers a suitable baseline before any major service changes were implemented in most councils.

Explanation of 6c

A contracts register has been drafted to showcase the current variety and potential alignment of all councils' contracts. This offers the opportunity for councils to highlight were potential collaborative working may occur in the form of either joint contract procurement or joint contracts.

This register is an update of the existing register from May 2013.

Other papers for item 6

Item 6e is a table from the County Council showcasing the disposal costs per collection authority, based upon the assumptions noted. There is a slight differences between the budget figures provided on the baseline spreadsheet (6b), and this table, as averages and assumptions have been used here to get a "district" figure. The "gate fee" for some contracts isn't as straightforward as a simple figure and at any one point in time will depend on numerous other things. As such, the County Council will be delivering a presentation on the financial structure of the disposal contracts the next Waste Officers meeting in November.

Item 6f is a verbal report from the County Council on the topic of the potential left to squeeze further savings from the HWRC contract with FCC, including the impact of shutting sites.

Other aspects to consider

• Funding grant;

SWP has been awarded a grant of £20,000 from the Local Government Association to spend on the project of collaboratively working together to produce savings for the Staffordshire tax payer. The bid application was specifically vague to enable SWP to conduct the project according to the as yet undecided direction of the project as to how the savings will be achieved long term. The money granted to us on several conditions –

- 1. Money must be spent by March 2016.
- 2. Money must be spent as a Partnership.
- 3. Progress must be reported monthly to the LGA using the provided templates.
- 4. Lessons learnt and key outcomes must be shared with the LGA and the wider local authority audience for sharing best practice.

As such, by the end of November (when the first progress report is due), the LGA are expecting a full outline of how the money is to be spent with an associated timeline. Therefore, these aspects need to be agreed at October's JWMB meeting, in item 8.

With this in mind, it has been suggested at SWOG that to avoid repeating work previously done by consultants on creating a joint waste authority, we use the funding to obtain current waste composition analysis and modelling of new collection service ideas, such as reduction of residual collections.

• Memorandum of Understanding;

Chief Executives Group have created and discussed a new Memorandum of Understanding to ensure councils are signed up to the same ethos of achieving cost savings, above and beyond the already established Joint Municipal Waste Management Strategy for Staffordshire and Stoke on Trent, and Joint Waste Management Board. The outcome of discussions and therefore sign up to the MoU following the 1st October meeting is unknown by SWP at the time of writing this report. Please contact your council's Chief Executive for an update prior to the JWMB meeting.

CXO meeting 7th October 2015 – Green Waste Credits

I would like to take this opportunity to thank you and the other Chief Executives for the positive engagement we had in regard to our waste management budgetary pressures and in particular the payment of credits for green waste composting. We had a very open and positive discussion about the need to think about the whole waste system across Staffordshire if we are to find savings for the public purse. To clarify our mutual understanding of the current situation, I would like to confirm the following points.

The County has an existing MTFS pressure of saving £1.5m from 16/17 onwards. The only current viable proposal would be to change the recycling credit to the WCAs for green waste to a cost of treatment only payment. The County Council has powers of direction which would allow us to enforce this change on the WCAs. However, we fully understand and sympathise with the financial and political pressures this would impose on the majority of the WCAs in Staffordshire and would wish to achieve these saving by other means if at all possible.

It was therefore agreed at the meeting that the county will not seek to impose this saving if the districts and boroughs agree to freeze the 3% inflation rise in the credit for green waste until 18/19. As I understand it, there is a Joint Waste Management Board meeting on 28th October where I hope we can brief our relevant Portfolio Holders to agree this proposition.

We also agreed that the Staffordshire Waste Partnership will also commit to working closely together in order to help SCC meet the £1.5m pressure we now have in our waste budgets through a holistic and pan county approach across collection, recycling, reuse and disposal functions within the county. I understand that this work is already underway and a timetable for presenting initial findings and suggestions has been put to the Partnership. It will not surprise you to read that the county will not be able to sustain this financial pressure indefinitely; if the partnership is unable to find the savings across the system by 2019 then it is highly likely that SCC will have to revisit options for making the saving, which would not exclude revisiting Green Waste Recycling Credits. However, I am confident based on the almost 6 months I have spent in Staffordshire that we have the capability, innovation and drive between us to make this happen.

I look forward to seeing all of you on 5 November in Lichfield.
