11. Election of Chairman and Vice-Chairman

Nominations had been received for Rev Preb Michael Metcalf and Hifsa Haroon Iqbal to be elected as Chairman and Vice-Chairman respectively. No further nominations were received and it was:

RESOLVED – That Rev Preb Michael Metcalf and Hifsa Haroon Iqbal be elected as Chairman and Vice-Chairman respectively for the ensuing year.

12. Welcome to New Members

The Chairman welcomed Andrea Hopkins, Salvation Army representative, Linda Goodwin, NUT representative and Lauren Nicholson-Ward, Church of England representative, to the SACRE.

13. Minutes of the SACRE meeting held on 6 July 2016

RESOLVED – That the minutes of the SACRE meeting held on 6 July 2016 be confirmed and signed by the Chairman.

14. Minutes of the Agreed Syllabus Conference held on 6 July 2016

RESOLVED – That the minutes of the Agreed Syllabus Conference held on 6 July 2016 be confirmed and signed by the Chairman.

15. Update on Key Issues

The SACRE received an update on key issues that had occurred since their last meeting, including:

a) A report had been produced by the All Party Parliamentary Group (APPG) on RE as a result of enquiring into Religious Literacy. Many of the notable points within "Improving Religious Literacy" were reflected well within the new Staffordshire

- Agreed Syllabus for RE. Ten of the report's recommendations related to RE and many of these were concerned with ensuring that RE is taught to a consistent standard of excellence by specialist or properly prepared teachers who have good access to continuing professional development.
- b) In a bid to halt any confusion surrounding the need to include both religious and non-religious views in religious studies, the DFE have issued some clear advice. Members considered the guidance note in full.
- c) An Independent Commission has been established by the Religious Education Council (REC) to make wide-ranging recommendations in relation to RE in schools. NASACRE is an important member of the REC and was encouraging member SACREs to include a discussion about the Commission on future agendas.
- d) Members were encouraged to follow both NASACRE and Entrust on Twitter for news, ideas and updates.

RESOLVED:

- a) That the update on key issues be noted; and
- b) That, in the light of the APPG report, and the results of the annual survey on RE provision in Staffordshire considered at the meeting in July, an item on the training of staff delivering RE in schools be included on the agenda for the next meeting.

16. NASACRE Update

The Chairman gave an update on recent NASACRE events, including:

- a) The NASACRE Annual Meeting is to take place on 16 May 2017 at the Hilton Hotel in York and the speaker was Joyce Miller;
- b) A joint conference was to be held with AREIAC in Birmingham on 6 March 2017; and
- c) The next round of awards were being announced by the Westhill Foundation, the deadline for submission of applications was the end of March 2017.
- d) A colloquium on Citizenship, Religion, Philosophy and Values in Education had sent a letter to the Secretary of State for Education to urge the Government to promote Citizenship, RE and PSHE in order to build respectful schools and Societies in post-Brexit Britain.
- e) The Chairman tabled copies of the proposed revised NASACRE Constitution for members' consideration and views. It was agreed that the response to NASACRE should be that the Staffordshire SACRE was broadly in support of the changes.

RESOLVED – That the oral update by the Chairman be noted.

17. Tell MAMA Annual Report 2015

The Tell MAMA Annual Report was launched in Parliament on 29 June and highlights hate crime against Muslims in the UK. "The Geography of Anti-Muslim Hatred" looked at where Muslims reported hate crime against them. Some key points emerged:

- The majority of hate crimes were directed at women who were visibly Muslim;
- The majority were perpetrated by white males; and
- The majority occurred on or near an A Road or transport hub.

Of particular concern to SACRE was that 20% of attacks were in places of education. The report commented that it was important that headteachers, teachers, and safeguarding leads in schools are trained to deal with Islamophobia and ant-Muslim hate.

Members were informed that many of the notable points relating to education are reflected well within the aims of the new Staffordshire Agreed Syllabus, through which schools are given a steer to include Islam within their programme of study.

Members agreed that they would like clarification on any issues which were being experienced in Staffordshire and what actions were being taken to ensure that Muslim pupils are kept safe. To this end, they agreed that the Police and Crime Commissioner, Matthew Ellis, should be invited to a future meeting to speak to SACRE about this issue in schools. SACRE also requested that a letter be sent to the LA for information on any initiatives that were taking place to help tackle the issues raised in the report.

RESOLVED – That the Police and Crime Commissioner be invited to a future meeting, to inform SACRE of Staffordshire's position on hate crime in schools and how it is addressed.

18. The Revised Staffordshire Agreed Syllabus for Religious Education 2016

The revised Staffordshire Agreed Syllabus was freely available to all schools on the Entrust RE website. Feedback had been positive and the uptake of a series of introductory training sessions for schools had been high. It was possible that the Syllabus would be adopted by other SACRES. Members agreed that it was important that the Syllabus be given an official launch, although there were concerns around funding owing to the current spending controls. It was agreed that the possibility of a launch in the New Year be investigated by the Chairman, Emma Jardine-Phillips and the Finance Team at the County Council. A costing would be put together for a drop-in session between 2 – 5 pm, with a speaker and a list of signposting details to resources to take away.

RESOLVED – That funding for an official launch of the revised Staffordshire Agreed Syllabus be investigated.

19. SACRE Annual Report

SACREs are required to produce an annual report of their work. This report would distributed electronically to NASACRE and headteachers of all schools in the County, and would be available to teacher associations and local faith communities via the Entrust website. SACRE were requested to read and approve the report prior to general distribution.

RESOLVED – That the report be emailed to members and any comments and/or amendments be submitted to Emma Jardine-Phillips by the end of November.

20. Accord Award

The 2017 Accord Inclusivity Award was seeking to reward those SACREs who work hardest in their area towards boosting the growth of inclusion, cohesion and mutual understanding between those of different religions and beliefs.

Members had group discussions on their work and achievements in this area to decide whether Staffordshire SACRE should complete an application form, paying particular attention to the guidance set out in the application form. In considering the guidance members expressed disappointment about the number of activities listed which SACRE was no longer involved with owing to budgetary constraints.

RESOLVED – That an application be made for an Accord Award.

21. Applications for Variation of Practice

22. SACRE Budget 2016 – 2017

SACRE received a breakdown of the current SACRE budget for the financial year 2016 – 2017. The balance remaining was £5,705.00.

The REC launches independent Commission on RE

An independent Commission has been established by the Religious Education Council (REC) to make wide-ranging recommendations in relation to Religious Education (RE) in schools. The Commission has been asked by the REC to review the legal, education and policy frameworks for RE in all primary schools, secondary schools and further education colleges in England. More information about the Commission, including its membership, can be found on the REC website.

NASACRE is an important member body of the REC recently urged member SACREs to send any recommendations, suggestions, etc., to the Chair. The deadline for submissions is the 13th Feb 2017 so a submission has been sent on SACREs behalf.

Introduction

The Commission on Religious Education (CoRE) is an independent body that was established to review the legal, education, and policy frameworks for religious education (RE) and to make evidence-based recommendations for policy makers and educationalists to consider. CoRE presents a 'once in a lifetime' opportunity to think deeply and broadly about the character, significance and role of religious education in our current local, national and global context. CoRE will publish an interim report in mid-2017 and a final report in mid-2018. CoRE consists of fourteen Commissioners, all appointed as individuals, with a wide range of expertise in RE or in other relevant areas. Short pen portraits of Commissioners are available here-education individuals, with a wide range of expertise in RE or in other

This call will form part of CoRE's efforts to gather the evidence on which the Commissioners will base their recommendations. CoRE is keen to hear from as wide a range of people and organisations as possible. All responses to this call will be made available in full to all Commissioners. When directed by CoRE, the secretariat of CoRE will provide an analysis of the responses. Your response to this call will not be published without your permission.

This call for evidence will not be the only opportunity to submit evidence to CoRE. Commissioners are currently considering additional ways for people to submit to CoRE, providing opportunities to contribute throughout the tenure of CoRE, although the later evidence is submitted, the less opportunity Commissioners will have to consider it before the drafting of the interim report. CoRE does not want to restrict the type of evidence submitted. There is no restriction on the type of evidence that can be submitted. Though CoRE believes that a degree of structure in the evidence will be helpful, and hence the questions below, it is also possible to submit evidence directly via the Core website. Full details for submitting evidence directly via the website can be found here.

CoRE was established by the Religious Education Council of England and Wales (REC) but is independent of it. The REC provides secretariat services to CoRE, but has no editorial control over the reports and recommendations that CoRE produce.

Parameters of the Commission

The Commission on Religious Education is considering RE in all schools and colleges in England that educate pupils of any age up to 19, irrespective of whether they are mainstream, special or alternative provision, independent or maintained, and of a religious character or not.

Employment of staff on the basis of their religion

- 2.2 The Staffordshire Agreed Syllabus has been reviewed and the re-write is complete.
- 2.3 The revised Agreed Syllabus has now been published and is available to schools.

4 Background

- 4.1 The revised Staffordshire Agreed Syllabus was issued to schools in September 2016 at the start of the new school year. The syllabus is freely available to all schools on the Entrust RE web page.
- 4.2 Schools have been made aware of the new agreed syllabus via internal school publicity e.g. the eschool bag and direct emails. The advisor to SACRE has received much interest and enquiries regarding the syllabus. There have also been several local articles in the press about the new syllabus and the Chair of SACRE was invited to speak on radio Stoke.
- 4.3 A series of introductory training sessions have been made available to schools. The uptake is high with most courses being full and one with a waiting list. Clusters of schools have also invited Emma Jardine-Phillips to host sessions within their schools.
- 4.4 Despite the efforts outlined, at the November SACRE meeting members raised issues that some schools still had not heard about the new Agreed Syllabus so it was resolved that members would consider the possibility of holding an official launch event.
- 4.5 The launch took place on the 31st January 2017.

Get recognition for your SACRE's work in national Award

The 2017 Accord Inclusivity Award, is seeking to reward those SACREs that work hardest in their area towards boosting the growth of inclusion, cohesion and mutual understanding between those of different religions and beliefs. If your SACRE takes these aims seriously then please don't miss out on this rare opportunity for it to be recognised for its work. Until now the Award - which has run every year since 2010 - has rewarded schools in England and Wales that excel on these grounds. For the 2017 Award however judges have decided to only invite nominations for SACREs, given the important role SACREs can play through their work in promoting respect, empathy and social cohesion.

Religious Education has always been of key importance for Inclusivity Award judges, who have consistently rewarded schools for excellence in the subject (and often thanks to recommendations from SACREs). For example, the first placed school in 2013, Little Heath School in Redbridge, won strong praise from judges for its approach to RE which was later highlighted by Ofsted as an example for other special schools to follow. Newbury Park Primary School in Ilford came first in 2014 for its 'Ambassadors of Faith and Belief' scheme that was supported by its SACRE and which served to help improve pupils understanding of the nature of faith and belief as a real life experience. The winning school in the 2016 Award, the Chestnut Grove Academy in Balham, stood out for the way in which its RE deepened and extended pupils' knowledge and understanding of religion and belief while simultaneously dealing with a range of controversial issues, such as around sexual diversity, homophobia and gender. But this coming year presents a chance for SACREs themselves to shine.

The Award is free to apply for. The full line up of another respected and experienced panel of experts will soon be announced. Previous judges have included former Secretary of State for Education, Lord Baker; the Chair of the Education Select Committee, Neil Carmichael MP; the then Chair of the Religious Education Council of England, John Keast OBE; the Bishop of Buckingham, The Rt Revd Dr Alan Wilson, and journalist Polly Toynbee.

RE is subject to many demands and pressures. If your SACRE works hard at trying to ensure local schools provide inclusive and high quality RE and assembles that take seriously the promotion of the growth of mutual understanding between those of different beliefs and backgrounds, then please make sure someone is mandated to submit a completed nomination on its behalf.

In the Staffordshire Agreed Syllabus for Religious Education, legal requirements state that RE should be provided as part of the basic curriculum for all registered pupils attending a maintained school.

At Key Stage 4 all pupils should fulfil their entitlement by following as a basis an accredited specification (from a recognised examination board) in Religious Studies. Schools should provide reasonable time for pupils to complete this and if appropriate, to attain an external qualification.

At KS5 pupils may follow the programme of study provided within the Agreed Syllabus or an accredited specification (from a recognised examination board) in Religious Studies.

Staffordshire SACRE recognises the independence of Academies and Free Schools. However, it commends the Agreed Syllabus to them as a constructive and collaborative way to meet their legal requirements in Religious Education.

In line with the SACRE remit, the analysis of GCSE and A level results that follows only takes account of local authority maintained schools.

Points to note:

- Overall, both national results and Staffordshire's results for GCSE Religious Studies in 2016 are broadly in line with overall results achieved in 2015. In 2015 the National Average A* to C was 70.6% (72% in 2014) and the Staffordshire Average A* to C was 68.4% (68.5% in 2014)
- Results for all pupils show that pupils in Staffordshire achieved slightly below the national average at grades A*-C but in line with the national average for grades A*-G. The results for both male and female pupils reflect the results for all pupils.
- However, a closer look at the results tables reveal that there were several schools achieving results well above the national average. SACRE members may wish to congratulate these schools on their achievements.
- When looking at the results for all pupils SACRE would be mindful to take note of the number of pupils on role versus the number of entries. This gives an insight into the provision that different schools have in place for pupils at KS4.

Points to note:

- Overall, both national results and Staffordshire's results for A Level Religious Studies in 2016 are broadly in line with overall results achieved in 2015. In 2015 the National Average A* to B was 54.5% (51.7% in 2014) and the Staffordshire Average A to B was 52% (42.6% in 2014).
- Results for all pupils show that pupils in Staffordshire achieved slightly below the national average at grades A*-B but broadly in line with the national average for grades A*-E. The results for female pupils reflect the results for all pupils. The results for male pupils revealed that they performed below the national average.
- However, a closer look at the results tables reveal that there were several schools achieving results well above the national average. SACRE members may wish to congratulate these schools on their achievements.
- The number of entries per school is small. This is not unexpected at KS5 for which examination courses will be optional.
