15. **RESOLVED** – That the minutes of the meeting held on 18 July 2017 be confirmed and signed by the Chairman.

Matters Arising

Financial Update

(schedule 1)

16. With regard to minute Nos. 8 and 9, the Environment Manager – East Staffordshire Borough Council circulated further details of the Partnership's Income and Expenditure account which took account of the comments made at the previous meeting ie (i) that External Funding and; (ii) projections for 2017/18 to 2019/20 should be shown.

He highlighted that during 2018/19 expenditure was predicted to exceed income by £6,780, a shortfall which could be met from reserves. However, he proposed that the matter be considered by the Staffordshire Waste Officers Group in order to find a longer term solution to projected deficit positions eg by increasing Partner Contributions and for them to report back to the next meeting of the Board, as necessary.

- 17. **RESOLVED** (a) That the revised income/expenditure account for 2016/17 and projected positions for 2017/18, 2018/19 and 2019/20 be noted.
- (b) That the Staffordshire Waste Officers' Group consider how future deficit positions in the Partnership Income/Expenditure account could be addressed and that they report back to the Board at their next meeting.

Strategic Waste Management Board Action Plan – Performance Report (schedule 2)

18. The Board considered a report of the Chairman of the Staffordshire Waste Officers' Group regarding progress made towards delivery of the Strategic Waste Management Board Action Plan during Quarter 1 2017/18.

In presenting the report, the Waste Partnership Manager highlighted that data for the previous three quarters had been included in the tables in order to aid comparisons (i) over time and; (ii) between areas. In addition, a graph illustrating performance under NI192 over time (2013 to 2017) was also provided

With regard to NI 191: "Residual Household Waste Collected per Household", Partnership performance had been mixed when compared to the figures for Quarter 4 2016/17. However, when compared to Quarter 2 2016/17 only Staffordshire Moorlands District had collected less residual waste.

With regard to NI 192: "% of Household Waste Sent for Re-Use, Recycling or Composting, the position was more encouraging in that all Authorities' had performed better when compared to Quarter 4 2016/17. However, garden waste recycling rates varied according to the season and therefore comparisons between Quarters 2 had to be treated with some caution.

Members were pleased to note that, since their previous meeting, Stoke-on-Trent City Council's statistics had been made available. From this data, it could be seen that Performance in NI191 and NI192 had improved when compared to both Quarters 2 and 4 2016/17.

The Waste Partnership Manager referred to the graph depicting performance with regard to NI192 Recycling Rate over time (2013 to 2017) which had been included in the data. Whilst the figures for 2016/17 were not yet available, it was hoped to have received these by the time of their meeting. In addition she highlighted the red line shown in the graph which indicated a 55% recycling rate target for all Waste Collection Authorities. Staffordshire Moorlands District Council had reached their target during 2015/16 (the most recent data available).

During the discussion which ensued the Member representative of Cannock Chase District Council welcomed the changes which had been made to the Performance Report. However, he requested the inclusion of data relating to the contamination of waste to be included in future reports to the Board. In reply, the Waste Partnership Manager undertook to ensure that the relevant waste data flow statistics were included, requested.

- 19. **RESOLVED** (a) That the report be received and noted.
- (b) That the relevant waste data flow statistics relating to waste contamination rates, be included in future performance reports to the Board.

Joint Waste Projects - Update (Schedule 3)

- 20. The Board received progress reports in respect of the following projects from the Staffordshire Waste Partnership Manager:-

Following her presentation of the report, the Waste Partnership Manager highlighted that the current Partnership Strategy ran until 2020. Therefore, a further project for refreshing the strategy would be included in the work programme, in due course. However, preliminary work had already commenced at officer level.



Joint Waste Management Board Partnership General Update

In additional to the recent work on holistic savings / charging for garden waste and development of a new recycling credit methodology, the following updates have also occurred in the last 2 months;

Legal dispute

The ongoing legal dispute with Biffa has yet to reach a suitable resolution. Following a final meeting with Biffa where lengthy discussions were held on meets the needs of both parties to avoid going to legal mediation / court, the councils issued a formal proposal to Biffa. This was both misunderstood and rejected. The councils have since provided clarification and a final compromise offer. If Biffa reject this proposal, legal mediation is likely to occur, despite both parties not wishing to undertake an official legal court battle.

Noise policy

Unfortunately, the dedicated Health and Safety meeting to discuss the creation of a noise policy was very poorly attended, with attendees from SoTCC, CCDC and L+TJWS only. Following this, requests for information have been made but not responded to and focus has moved on to recycling credits etc. This project will be resumed when it can be given full attention.

Fly-tipping data

Historic fly tipping data from April 2015 to September 2017, per quarter, has been collated and submitted to JWMB as part of the usual data spreadsheet standing agenda item. This data has independently been collated from WasteDataFlow directly. The data will be updated every quarter, as it also done with the recycling data.

Strategy post 2020

No development has occurred on the beginnings of strategy creation, as larger issues, such as recycling credits and charging for garden waste collections, has taken precedence in recent discussions at SWOG level. Once these issues have provided a direction of where we are going long term, we will be able to develop a strategic direction to enhance our performance alongside these existing decisions.

TOG

The Transport Officers Group are meeting in January at the Hako headquarters in Crick for a morning session comprising the usual group meeting for knowledge sharing between councils, and additionally including a tour of the Hako facility, a demonstration of new sweepers, and a presentation on recent developments within the company.
