STRATEGIC OUTCOMES

- Root causes are identified and addressed to prevent problems from occurring or escalating
- Problems are prevented through police, partners and the public taking a problem solving approach
- People are effectively diverted away from and within the criminal justice system

ACTIVITY SINCE LAST REPORT

- The Prince's Trust supported 70 young people this quarter.
 74% of young people engaging in the programme as a whole have achieved a positive outcome (education, training or employment).
- Catch 22 completed 445 Return Home Interviews (RHI) with children missing from home. 75% of young people who go missing receive a RHI (in line with local targets). Catch 22 supported 94 children at risk of CSE or victims of CSE.
- Barnardo's supported 170 individuals on FGM-related issues (children and adults, males and females). 132 professionals have been trained on FGM.
- The Prince's Trust, in collaboration with the Commissioner's Office, developed a proposal for the next three years.
- Service Specification for the Youth Offending Prevention Service developed in line with recommendations from the independent review of the Youth Offending Prevention service.
- The Commissioner's Office have been successful in their bid to the Home Office Early Intervention Youth Fund (EIYF).
- The Commissioner's Office have agreed for SCFC Community Trust to deliver a small peer mentoring project.
- As part of the Staffordshire Domestic Abuse Strategy a multiagency task group has been set up to deliver the DA Prevention and Early Intervention delivery plan.

PLANNED ACTIVITY BEFORE NEXT REPORT

- Establish agreement for the continuation/growth of the Princes Trust project.
- Agree timeline for CSE/Missing service (likely to incorporate wider remit of Child Exploitation) in line extension of current service for six months (1 April 2021 commencement date).
- Agree any amendments to the Youth Offending Prevention Service with the YOS Managers/YOS Boards.
- Agree implementation plan for the EIYF.
- Develop implement plan for Peer Mentoring project.
- Ratification of the Child Exploitation Strategy by the Safeguarding Children Board Partnership Group.
- Progress actions in the DA Prevention and Early Intervention delivery plan.
- Advertise and recruit to a PSHE/Vulnerability Education Co-ordinator for Stoke-on-Trent.
- Cannock schools to purchase/implement agreed online safety resources and evaluate programme.
- Implement the Harmful Sexual Behaviour Strategy.
- Implement Youth Offending Prevention Service specification and undertake quarterly performance meetings (SCO and YOS).
- Recruit to staff/develop projects in line with the EIYF proposal/funding.
- Monitor outputs and outcomes for peer mentoring project.

- Space 2019 launch event will take place on 9 July 2019. The programme will run from 22 July until 30 August 2019 (www.staffordshirespace.uk)
- A full evaluation of SPACE 2019 will be produced by 31 March 2020.
