### **ACTIVITY SINCE LAST REPORT**

- Majority of actions included in Staffordshire Strategic Framework for Reduced Offending 2018-21 scheduled for delivery by end of Q1 2019/20 implemented.
- Outcome from recent YOS reviews considered by joint YOS Board meeting. Next steps agreed.
- Meetings held with NPS Regional lead re implementation of national Women Offenders Strategy.
- Arrangements agreed for formal launch of new IOM delivery model.
- Next steps agreed for implementation of offender employment brokerage service.
- Approach agreed with partners to the planned re-tendering of existing Floating Housing Support Services for Offenders.
- Meeting of Staffordshire Mental Health and Community Safety Strategic Board held to agree work streams and action plan. External support commissioned to take forward delivery of the Board's agenda.
- Additional investment agreed with Staffordshire County and Stoke-on-Trent City Councils to build treatment capacity to support increase in DRR and ATR delivery.
- Workshop held to explore support across agencies for introduction of Community Orders with Mental Health Treatment Requirement. Discussions held with NHS England and local treatment providers to progress development.
- New countywide performance dashboard introduced to support tracking of offending and reoffending outcomes.
- Meeting with MoJ and regional PCCs to discuss PCC role in national Probation re-design programme
- 156 cases were referred to the New Era perpetrator services to help those wishing to change their abusive behaviour.



- Further meeting of Mental Health and Community Safety Strategic Board held / Board Action Plan reviewed
- Further discussions held with NHS England and local treatment providers to progress development Community Orders with a Mental Health Treatment Requirement.
- Further meeting of OMCDB held
- Additional investment in drug and alcohol services to support increase in DRR and ATR delivery built into local commissioning arrangements. New substance misuse support workers recruited / additional prescribing clinics in place.

- The Staffordshire Commissioner's Office continues to work with Staffordshire Police Justice Services to develop an Out of Court Disposal programme for perpetrators of Domestic Abuse following the Force's pilot on behalf of the Ministry of Justice.
