You will only know this when you attend a meeting of the Council and an item on the agenda affects you or your spouse/partner to the extent described. You must then

declare the interest at the beginning of the meeting or before the item is discussed and not take part in the meeting for that item.

Section B: The following 'Other Interests' in accordance with Section 28(2) of the Localism Act 2011

Formal Bodies:

Under this section you have a personal interest in any business of the authority which relates to any body that you are a member of, or hold a position of general control or management and:

- have been appointed to, or nominated as a member of, by your Authority or
- exercises functions of a public nature or
- is directed to charitable purposes or
- has the principal purpose of influencing public opinion or policy (including Political Party or Trades Union)

When any item listed under Section B is being considered at a Council meeting you must declare the interest but can take part in discussions and any vote on the item.
