# **Decision Title**

Relocation of Newcastle Specialist Day Opportunities to Brackenberry site

## **Decision Required**

Proceed with the proposed refurbishment of the Brackenberry site and relocate the service

#### **Decision Date**

31<sup>st</sup> January 2023

#### **Decision Summary**

The recommendation is to refurbish and modernise the Brackenberry building and relocate the service to this site. The Brackenberry site offers a much better building for the service in terms of layout, flexibility, adaptability, and size in comparison to Wilmott Drive. Capital works would be funded using the Covid Outbreak Management Fund, as approved by Cabinet on the 19th of October 2022. The net present value of refurbishment and relocation would be £54,970 over a 15-year period. It would save the Council approximately £500,000 revenue costs in 2023/24 and around £150,000 annually thereafter. It would release the Wilmot Drive site for sale, which would realise at least £675,000 in capital receipts.

Feedback from both staff and carers about the proposed relocation was unanimously positive with no challenge.

# **Options Considered**

Staffordshire County Council provides Specialist Day Opportunities for twelve adults at the Wilmot Drive site in Newcastle-under-Lyme. The site is significantly under-utilised with nearly 400 square metres of surplus space and no plans or requirements for the surplus space identified. A property review in 2022 identified a unique opportunity to relocate the service to the recently vacated Brackenberry site, also in Newcastle-under-Lyme.

The two options considered were:

- 1. Retain the service at its current location on Wilmot Drive
- 2. Relocate the service to Brackenberry

A comparison of the two sites is shown in Table 1.

# **Community Impact Assessment**

Key Issues

#### Service Users and Carers

The Brackenberry site offers a much better building for the service in terms of layout, flexibility, adaptability, and size.

At Brackenberry the service would have 6 activity rooms of various sizes including 2 large rooms, 2 medium rooms, and 2 small rooms, compared to four large rooms at Wilmot Drive. This would offer more flexibility and better use of space for people with complex health needs and people with behaviours that challenge. The layout of the Brackenberry site lends itself to being able to easily separate these two groups of clients, which is a requirement to deliver a safe service.

Benefits of relocation to the Brackenberry site for service users and carers include:

- It is closer to local amenities
- The distance from the current premises to the new premises is one mile
- Improved infection prevention and control.
- An opportunity to modernise the environment including with Wi-Fi
- A net reduction in travel distances for clients of 5 miles per day.
- Client numbers could increase up to 15 people without an increase in staffing.

Feedback from carers and families about the proposed relocation was unanimously positive with no challenge.

#### Staff and Management

There are no changes to staffing as a result of this relocation. The staff's registered work base would need to change as a term and condition of their employment.

Benefits of relocation to the Brackenberry site for staff include:

- It is closer to local amenities
- Improved infection prevention and control.
- An opportunity to modernize the environment including with Wi-Fi
- A net reduction in travel distances for staff of 9 miles per day.

Feedback from staff about the proposed relocation was unanimously positive with no challenge.

#### Resource and Value for Money Analysis

A feasibility study carried out in early 2022 confirmed that the capital works required to make the Brackenberry site suitable for Specialist Day



Opportunities would require investment of around £1.8m. This would be funded using the Covid Outbreak Management Fund, as approved by Cabinet on the 19th of October 2022.

As the Brackenberry site is a lot smaller, the maintenance and running costs would be significantly lower than current costs of Wilmott Drive. This would save around  $\pounds$ 70k per annum. There would also be savings from providing the service to three additional clients, with costs avoided in the independent sector. A calculation of net savings and net present value is shown in the table below:

- Transport to the new service location will still be provided for those individuals where it is an assessed need
- The services will develop individual transition plans and risk assessments to help service users, carers and staff manage the change.
