- 18. *By* *Hopton* *Road* *between* *posts* *No.* *16* *and* *17* — *English* *State*.

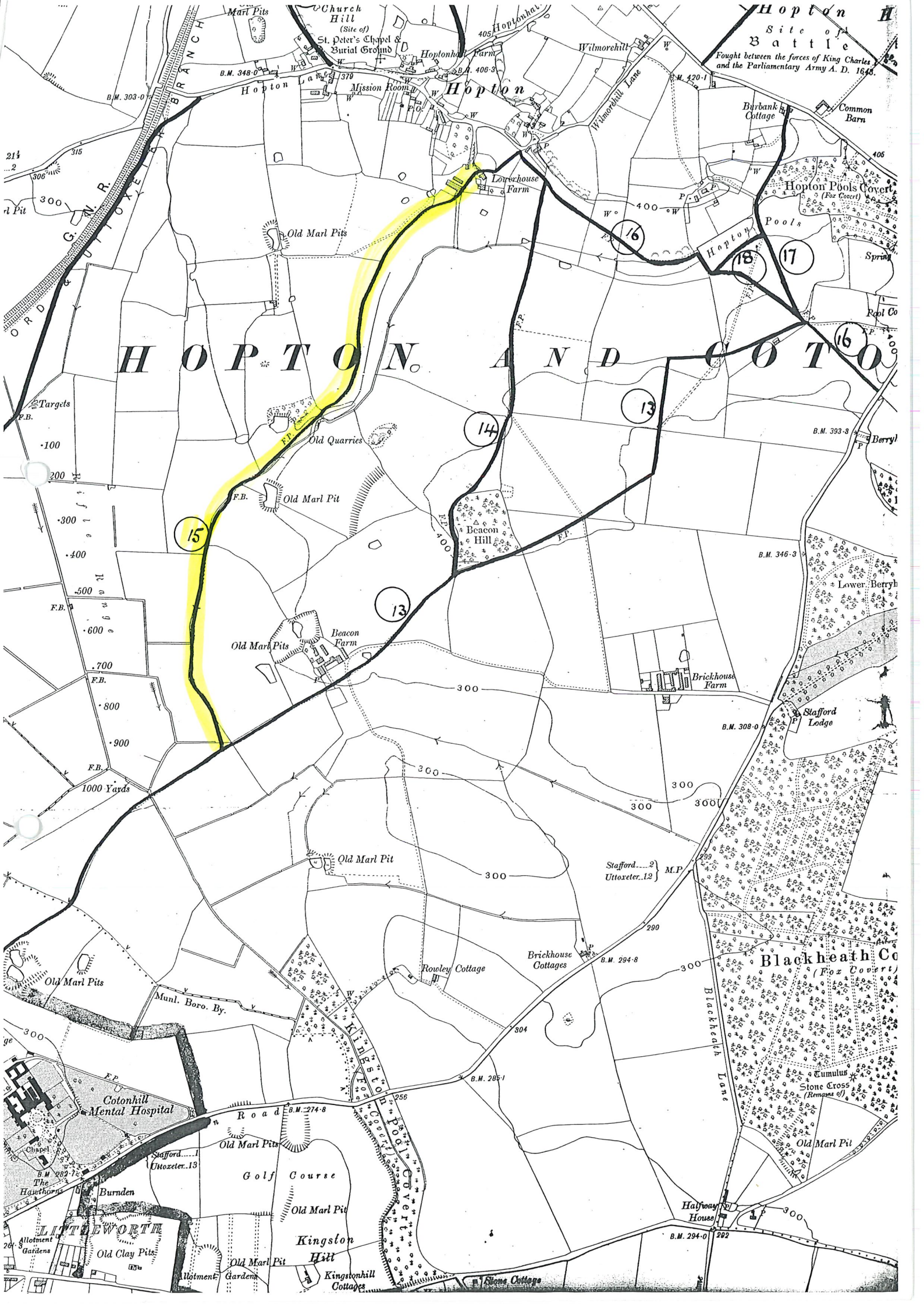
