Dear Sir,

Survey of Rights of Way - Hopton and Coton

We are now engaged on the final stages of preparing the Draft Maps and Written Statements for submission to the County Council and for placing on deposit for public inspection. In the course of this work we have had to pay particular attention to the question of paths which cross parish, local authority and county boundaries, while at the same time ensuring that so far as possible any apparent anomalies are reduced to the minimum. In the case of your parish it appears that:-

- (a) The western portion of Brick Kiln Lane extending for a distance of about 200 yards from Within Lane should be included in the survey as a road used as a path, as the continuation of this lane has been included in the Salt and Enson Parish survey.
- (b) The path shown on your survey leading from the direction of Ingestre Hall and terminating at Fiddler's Lodge should be continued to meet the Stafford-Uttoxeter Road at the south west corner of Pool Covert and also the the south of Pool Cottage.
- (c) The path shown on your survey leading northwards from a point near Beacon Farm to the village of Hopton near Lowerhouse Farm should be continued to Wilmorehill Lane as all public footpaths should give access to a public highway.
- (d) Two paths shown on your survey as being obstructed by 16 M.U. should be included in the survey as the closure of these paths was effected under the Defence Regulations and was, therefore, of a temporary nature. The two paths concerned are the southern portion of the path referred to in (c) above, and the path leading from Beaconside Road near the north end of Coronation Road to Hopton Lane east of the railway line.

- (e) A path should be included in the survey leading from Beaconside Road south-west of Beacon Farm to the boundary with Stafford Borough as although this path is now obstructed by the Air Ministry housing site the Stafford Borough Council have shown the continuation of their survey and considered that the right of way should be preserved.
- (f) The short length of roadway formerly forming part of the Tixall Road, east of Kingston Hill, should be included in the survey as a road used as a path to link the path over Kingston Hill, which is shown on the Stafford Borough survey, with the county road.

It is proposed therefore to make an amendment on these lines to the maps which will be formally submitted and a note will be made on the 6" maps and log cards prepared by your parish to the effect that the amendment has been made.
