They also noted three Additional Items for Discussion/Programme ie:- (i) Local Industrial Strategy/Strategic Infrastructure Plan; (ii) Delivering Housing in Staffordshire and; (iii) Live Labs) and a Working Group (Community Transport and the Supported Bus Network) which had been provisionally included. Owing to the wide-ranging scope of the Committee's remit and the various dates which had been included in the County Council's Calendar of Meetings for Prosperous Overview and Scrutiny Committee meetings, the Chairman sought authority to schedule-in items, in consultation with the Vice-Chairmen and report back to their next meeting, as necessary.
