"Dear Mr Adkins, thank you for the documents regarding the alleged footpath in Leigh parish which starts at our ground. I've read through it and I'm amazed! I know that you have to remain impartial, but here's a few of our concerns. 1) Its really quite difficult to walk through the boggy area as proposed. I've lived here for most of my years and can't get through without losing a Wellington. 2) There are curlews, field fares, snipe and lapwing in that area, plus an abundance of lady smocks. Are Natural England going to allow people to walk through it?, I very much doubt it. 3) I have the 1933 sale particulars from when the Bagot Estate was sold, all footpaths are marked and that isn't, yet the Lord Bagot owned the estate in the period where you say the information comes from regarding a path. 4) There is a path through our back yard which is about 100 metres on one side of the proposal, which is walked perhaps once every five years and Leigh Lane on the other side, both come out at the same point and would take no longer as you would not get stuck. We would welcome a visit by the Panel to see what we are saying. I will be informing the relevant organizations who I am sure will not encourage things to go ahead. On another point, why this has taken 21 years to come out as we have heard nothing before about this until a neighbour informed us? Regards, Jane Brookes"
